Terms of use of doctoral dissertations

- 1. Public access through Kobe University Repository Kernel
 - 1) Kobe University Library (Hereinafter referred to as the 'Library') shall copy an electronic version of the dissertation on the Kernel server and make the material accessible to the public. The use of the system is free of charge. Work must be available in full as electronic data. However, if the work includes any matters of copyright or private information protected or any other concerns, parts may be abbreviated or redacted.
 - 2) Library shall make metadata (title, author name, abstract, etc.) to the public.
 - 3) On occasion the author may wish to terminate or alter the consent conditions, the author may be allowed to amend the terms as necessary. (*1)
 - 4) Library shall notify and caution users on the following points.
 - · In use of doctoral dissertations, copyright law must be respected.
 - Library and the author accept no liability for any damages or disadvantages incurred by the user using the contents.
 - 5) If any question or matter occurs not stipulated in the terms it shall be resolved by consultation between the author and the Library as is necessary.

2. Copy permission of pages

- 1) In terms of use for education, learning, investigation and research, Library will provide one copy of all pages allowed of doctoral dissertations to users based on user's application.(*2)
- 2) The copyright charge is free. (But Library collects administrative charge for providers.)
- 3) Library applies for permission from authors each time applications do not correspond to the usual purpose of provision 1).
- *1 This permission allows the Library rights of reproduction and public transmission of all copyrights that the author has given. It does not mean the transfer of all copyrights from the author to the Library.
- *2 Library for Social Sciences preserves doctoral dissertations of all graduate courses that submitted to Kobe University. On occasion authors don't permit the copying of all pages, but must provide part of a copy to users under the article 31 of the Copyright Law. Thank you for your understanding.
